Heard .The learned counsel represented for the applicant. This is an application for fresh inter district regular permit in respect of a new or suitable stage carriage with seating capacity 48 in all to operate on the route Pala – Chemmannar (via) Bharananganam,Erattupetta,Vagamon,Upputhara,Kattappana,Pampadumpara,Nedumkandam,Udumbanchola as Limited Stop Ordinary service having route length 131 Km. There is no objectionable overlapping and virgin portion . In Kottayam District, there is an overlapping distance of 1.9 kms from Kottaramattam Bus Stand to Pala Old Bus Stand on the notified route Kottayam-Kattappana and in Idukki district there is an overlapping on the notified route Kottayam-Kattappana and Aluva-Kattappana having 700 mtrs at Kattappana to Idukki Kavala .But the overlapping is in the permissible limit of 5% of route length .There is no virgin portion . RTA Kottayam has granted and forwarded the concurrence vide letter No.G1/3468/2016/K subject to the right of original authority to verify the feasibility with the Government notification vide GO(P)No.42/2009 dated 14/07/2009. Hence regular permit is granted to a new or suitable stage carriage with seating capacity not less than 38 in all on the above route subject to settlement of timings as per the order No.D3/875/STA/2005 dtd 04-11-2011 of STA,Thiruvananthapuram. Secretary RTA is directed to conduct timing conference only on production of the current records of a suitable vehicle

Heard .The learned counsel represented for the applicant. This is an application for fresh inter district regular permit in respect of the stage carriage KL-6-H-227 or suitable stage carriage with seating capacity 38 in all to operate on the route Kattappana-Rajakkad(Via),Erattayar,Ezhukumvayal , Chempalam ,Kallar,Nedukanadam, Udumbanchola, Mangathotty and Rajakumary as ordinary service having route length 82 Km. There is no objectionable overlapping with any notified or nationalized schemes. No objections were raised against the grant of the permit. Hence regular permit is granted to the stage carriage KL-6-H-227 with seating capacity not less than 38 in all on the above route subject to settlement of timings. Heard .The learned counsel represented for the applicant. This is an application for fresh inter district regular permit in respect of stage carriage KL-37-1039 or suitable stage carriage with seating capacity 38 in all to operate on the route Nedumkandam- pala, touching, Melechinnar-via Manjappara, Eettithoppu, Kattappana Upputhara, Wagomon, Vazhikkadavu, Erattupetta, Bharananganam as Limited Stop Ordinary service having route length 56 Km. In Idukki district at Thodupuzha town there is an overlapping on the notified route Kottayam-Kattappana and Aluva-Kattappana having 900 mtrs. But the overlapping is in the permissible limit of 5% of route length .There is no virgin portion . Heard.The learned counsel represented for the applicant. This is an application for fresh intra district regular permit in respect of the stage carriage KL-57-9542 or suitable stage carriage with seating capacity 33 in all to operate on the route Idukki Medical College-Adimaly touching Maniyarankudy and Kanakakkunnu, via Cheruthony, Thadiyambadu, Chelachuvade, Kallarkutty, Chalicity, Upput hode, Charalanganam Murickassery and Thopramkudy as Ordinary Service having route length 78 kms. The learned counsel has produced a judgment of Honorable High Court before the RTA meeting. Honorable High Court in WPC NO.3633 of 2017 dated 03/02/2017 has directed to State Transport Authority to take a decision as to the age of the vehicles that could be used for conducting ordinary stage carriage services and the matter is being considered by the said authority. The writ petition can be disposed of subject to the outcome of the decision to be rendered by the State Transport Authority pursuant to the judgment of Honorable High Court Ordered accordingly, If the application of the petitioner is otherwise ripe, the same shall be taken up and considered in the meeting scheduled on 9/2/2017 itself. But The offered vehicle is not registered in the name of the applicant till date.Hence **rejected**.

This is an application for fresh intra district temporary permit in respect of the stage carriage- KL-7-BC-7406 or suitable stage carriage with seating capacity 48 in all to operate on the route Korangatty-Cheruthony touching Pazhayarikandam and Murickassery Via Adimaly,Kallarkutty, Panamkutty Chelachuvade,Kanjikuzhy and Karimpan as Ordinary Service having route length 68 kms. Heard The learned counsel represented for the applicant. This is an application for fresh inter district regular permit to the stage carriage KL 23 1867 with seating capacity 19 in all to operate on the route Vallakkadavu-Thengakkal via Kakki Jn,Vandiperiyar and Mlamala as ordinary service in the surrendered vacancy of S/C KL 57 B 5458 as O.S having route length 24 kms.There is an overlapping on the notified route Trivandrum-Thekkady and Thekkady- Ernakulam from Kakki Jn to Vandiperiyar-1.2Kms.It is exactly 5% of the total route length. Which is the maximum and permissible. The field officer reported that the proposed route is beneficial for the public and students. The portion of the route from Vandiperiyar to Thangakkal is not well served with stage carriage. Heard The learned counsel represented for the applicant. This is an application for fresh inter district regular permit to the stage carriage KL 06 B 9793 with seating capacity 30 in all to operate on the route Thengakkal-Vallakkadavu via Mlamala,Vandiperiyar and Kakki Jn as ordinary service in the surrendered vacancy of S/C KL 04 U 8377 as O.S having route length 24 kms.There is an overlapping on the notified route Trivandrum-Thekkady and Thekkady- Ernakulam from Kakki Jn to Vandiperiyar-1.2Kms.It is exactly 5% of the total route length. Which is the maximum permissible. The field officer reported that the proposed route is beneficial for the public and students. The portion of the route from Vandiperiyar to Thengakkal is not well served with stage carriage. Hence regular permit is granted to the stage carriage KL-6-B-9793 with seating capacity not less than 30 in all on the above route subject to settlement of timings. Secretary RTA is directed to conduct timing conference only on production of the current records of a suitable vehicle.

Item No.15

Heard The learned counsel represented for the applicant.This is an application for four month temporary permit in respect of Stage Carriage KL 33 8378 with seating capacity 48 in all to operate on the route Kumily-Kottayam via Vandiperiyar,Kuttikanam,Mundakayam,Ponkunnam,14th mile & Pampady as LSOS in the vacancy of KL 37 A 1915.

Stage carriage KL 37 A 1915 was permitted to operate on the route Kumily-Kottayam with regular permit valid upto 23/4/2017.The regular permit in respect of the route bus KL 37 A 1915 was under suspended animation, since clearance certificate of the vehicle was issued to RTO Kottayam by retaining the permit in compliance of the Judgement of Hon'ble High Court in WPC 11385 of 2014.The Hon'ble High Court has given liberty to Secretary RTA to specify a time period for replacing the route bus with a suitable stage carriage. In obedience to this , a direction has been given to the registered owner of the vehicle KL 37 A 1915 as per KMV RULES 1989 to offer a vehicle to operate on this route within 4 months from 20.05.2014 failing which the permit will be revoked .But the permit holder has not produced any suitable vehicle to operate on the route and RTA Idukki cancelled this permit as per order No.G/2953/2015/ID dtd 29/1/2015 29/5/15.The orders of RTA has been stayed until further orders by Hon'ble STAT in MP No 519/2015 in MVARP No 84/15 dated 18/6/2015

In this circumstance,the owner of stage carriage bearing registration no KL 34 D 2765 applied for temporary permit on the route Kumali-Kottayam in the vacancy of stage carriage bearing registration No KL 37 A 1915, In WPC No 14212/2015,Hon'ble High Court has directed the Secretary RTA,Idukki to consider the application for temporary permit and issue the same. Hence temporary permit for 4 months was issued for period upto 19.1.2016. There after temporary permits for period upto 28/3/2016 also were issued in respect of stage carriage KL 34 D 2765 and KL 63 9420.On 24-11-2016 Sri.Riyas A,Mubarak Manzil,Vandiperiyar has produced copy of the judgement dated 17/11/2016 of Hon'ble High Court in WPC 36856 of 2016(F) directing Secretary RTA to grant temporary permit in the defaulted vacancy of KL 37 A 1915.Accordingly substitute temporary permit was issued in respect of stage carriage for the period from 24.11.2016 to 13.12.2016.Sri.Riyas has applied for reissue of the temporary permit from 14/12/16.He has filed WPC 39751/16(t) before the Hon'ble High Court against non reissue of temporary permit.Smt.Aniyamma Kurian,Thekkanattu(h),Thottakkad has impleaded as additional respondent in this WPC.The Hon'ble High Court as per judgement dated 16.12.2016 has directed RTA to consider the application for reissue of temporary permit

within 10 days from 16/12/16 and take appropriate decision taking into account the objection filed by the second respondent. KSRTC also has objected the reissue of this temporary permit. Hence the application was submitted to RTA for consideration under KMV Rule 130.

In obedience to the direction of DTC, Ernakulam (Member RTA, Idukki) an application for extension of time limit to comply the direction of Hon'ble High Court was filed before the Hon'ble High Court by Secretary RTA and the objector Smt. Aniyamma Kurian and inspector of KSRTC were heard in person. Representative of Smt. Aniyamma Kurian had submitted that if this permit is granted it will adversely affect her service on the route Kottayam-Mathamba and so time should be settled before granting this permit. Inspector of K.S.R.T.C has submitted that this is a notified route and so grant of temporary permit/Regular permit on this route will be against the notified scheme and so is not legal.

Another objection is received on 19-1-2017 before the Hon'ble Chairman from one Sri. Binu John stating that this permit should not be granted by circulation of file and that the application should be considered in an open RTA meeting. Hon'ble High Court has extended the time limit prescribed in the judgement in W.P.(C) No.39751/2016 for a further period of three months from 26-12-2016.

In these circumstances this authority hereby order and deliver the following

- 1) The regular permit was revoked by RTA on 29/1/2015
- 2). The revocation of regular permit is stayed by the Hon'ble STAT until further orders as per interim orders dated 18/6/15
- 3) This is a notified route fully overlapping the Kottayam-Thekkady nationalization scheme. As per GO(P) No. 42/2009/Tran dated 14/07/2009 and as per para 33 of the judgment of Honorable High Court in WP(c) No.14793 of 2006 dated 10/04/2015, the Chief Executive Officer of the STU is the competent authority to determine the traffic demand of a nationalized route. In para 15 of the judgment of Honorable High Court in WA 670/2014 dated 05/02/2016, it is held that issue of additional permit apart from the scheme will **upset the scheme**, which is legally impermissible.
- 4) The argument of the 1st objector is that since the regular permit is not alive, temporary permit can't be issued
- 5) DTO, KSRTC Thodupuzha has submitted that this is a notified route and so issue of temporary permit in the vacant timings of a non existing service is against the notified scheme.

Hence the application for four month temporary permit is hereby **Rejected**

This is an application for fresh temporary permit in respect of stage carriage KL 35 C 6651 to operate on the route Panickankudy-Ranni via Mukkudam, Platheri, Adimaly, Kothamangalam, Muvattupuzha, Thodupuzha, Muttom, Melukavu, Erattupetta, Kanjirappally, as LSOS in the surrender vacancy of S/C KL 40 H 4676.

On 28/01/2017, Sri.Dinesh P C applied for a four month temporary permit on the route Panickankudy-Ranni in the surrender vacancy of KL 40 H 4676, the Sec.RTA Idukki called for a detailed report from the circle officer. On 09/02/2017, Sri.Dinesh P C, produce the judgement of Hon. High court of Kerala in WP(C) No.3498 of 2017(J) directing the secretary RTA Idukki to consider the temporary permit application and grant temporary permit sought by the applicant without prejudice to the right of the regular permitholder to resume service, if there is no other better claimant for the grant sought by the petitioner within two weeks from the date of receipt of a copy of the judgment.Copy of the judgement is received on 09/02/2017.This is an inter district route having route length of 183 Kms.Out of this 12 Kms from Achankavala to Muttom overlaps in the Aluva-Kattappana notified route in Idukki District and 16 Kms from BOC Junction Muvattupuzha to Achankavala overlaps in the Aluva-Kattappana notified route within jurisdiction of RTO Muvattupuzha and a 24 Kms from Kanjirappally to Placherry overlaps on the Changanacherry-Changanacherry circular scheme in Kottayam district.

In these circumstances this authority decides as follows.

1. The regular permit and temporary permit are not alive since both were surrendered. Hence this is a fresh permit application.

2. As per GO(P) No. 42/2009/ Tran dated 14/07/2009 and as per para 33 of the judgment of Honorable High Court in WP(c) No.14793 of 2006 dated 10/04/2015, the Chief Executive Officer of the STU is the competent authority to determine the traffic demand of a nationalized route. In para 15 of the judgment of Honorable High Court in WA 670/2014 dated 05/02/2016, it is held that issue of additional permit apart from the scheme will **upset the scheme**, which is legally impermissible. If it is granted, it is the clear violation of GO(P) No. 42/2009/ Tran dated 14/07/2009.

Hence the application for temporary permit is hereby **Rejected**

Later on 12.06.2012 Hon'ble STAT directed to grant renewal of permit as Fast Passenger Service and RTA on 22.08.2012 granted the same subjected to remittance of prescribed fee for variation and a suitable vehicle to be operated as Fast Passenger service in accordance with Rule 260(a) of KMV Rules. But such current records were not produced by the applicant

On 20.10.2015 the permit holder again applied for renewal of permit as LSOS and applied for temporary permit for 4 months. As the regular permit granted by RTA,was not availed by the permit holder this application was rejected by secretary,RTA. The permit holder filed WP© No.37916/2015 before the Hon'ble High Court and the Hon'ble High Court has directed secretary RTA to consider the temporary permit application within 2 weeks. Accordingly secretary RTA as directed in GO(MS) 45/15 TRAN dtd 20.08.2015 had granted temporary permit to the stage carriage KL-33-6743 to operate on the route Kuzhitholu – Changanacherry as LSOS

On 20.06.2016 the permit holder applied for replacement of vehicle under lease agreement with Sanal.S.George, and produced the later model stage carriage KL-33-H-3638.But the regular permit of the vehicle was expired on 12.12.2010 and the vehicle was conducting service on 4 months temporary permit issued as per the direction of Hon'ble High Court. As the applicant has not availed the renewal of permit granted by RTA on 14.02.2012, this regular permit is not in existence at present. Hence there is no legality in replacing the vehicle. So Secretary RTA Idukki rejected the application for replacement of vehicle on this route.

The Permit Holder had filed WP(C) 21961 of 2016 before the Honorable High Court against the rejection of replacement and the Honorable High Court has directed RTA to consider the application for renewal of permit submitted on 20/10/2015 within two weeks and thereafter the Secretary may reconsider the replacement application on its merit. So RTA, Idukki considered the renewal application by circulation of files and as per proceedings dtd.29/07/2016 the application was rejected.

The Permit Holder filed MVAA No. 147/2016 before Honorable STAT against the rejection of renewal of permit and the Honorable STAT vide Mp No.488/2016 dtd. 26/11/2016 allowed to continue the service U/S 214(2). On 13.01.2017 the permit holder intimated that the vehicle was sold to Sri.Jobins M.T., S/O Thomas, Muringayil, Muttom, Thodupuzha and applied for clearance certificate without cancelling the regular permit and with option to offer new vehicle if renewal is granted by Honorable STAT. This application was rejected by Secretary, RTA and permit holder has filed WP(C) 567 of 2017 before Honorable High Court. Honorable High Court has directed Secretary RTA to consider the matter within two weeks and also to issue temporary permit till the renewal application is disposed by the appellate authority. So clearance certificate was issued on 13/01/2017 without cancelling the regular permit. Meanwhile in MPNo.480/2016 dtd.01/10/2016 Honorable STAT has directed to grant temporary permit for stage carriage KL 33 H 3638 for 15 days on this route in place of KL 33 6743. At present the temporary permit so issued for KL 33 H 3638 is valid up to 19/04/2017. On 27/12/2016 Honorable STAT had issued final judgment in MVAA No.147/2016. The Honorable STAT had set aside the rejection of regular permit with the following observations.

1. If the grantee of the permit failed to produce the certificate of registration within the stipulated time RTA may revoke the sanction for permit. In this case such revocation of the grant is not made.
2. It is necessary to give the applicant a fair hearing and pass orders on merits. The application for renewal was rejected by RTA by circulation of file under rule 130 denying the applicant an opportunity of being heard.

So Honorable STAT has remanded the renewal application for reconsideration after hearing the applicant,. In the light of observations made in the judgment RTA may hear the applicant, peruse the judgment and decision may be taken.

In the light of the direction of Honorable STAT it is necessary to consider the revocation of the grant of renewal of permit as Fast Passenger . Hence **adjourned.**

Secretary RTA Idukki is directed to submit agenda notes in the next RTA Meeting for considering the revocation of sanction for renewal of this permit.
